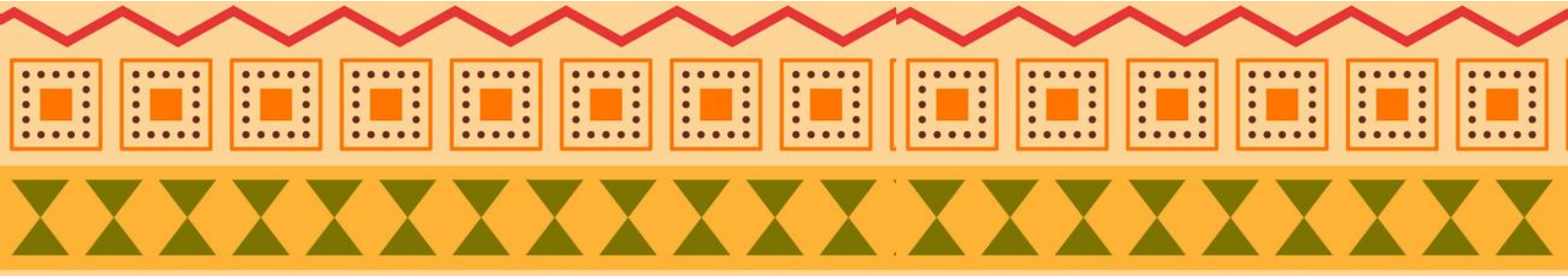
# Sustainability and Future Plans

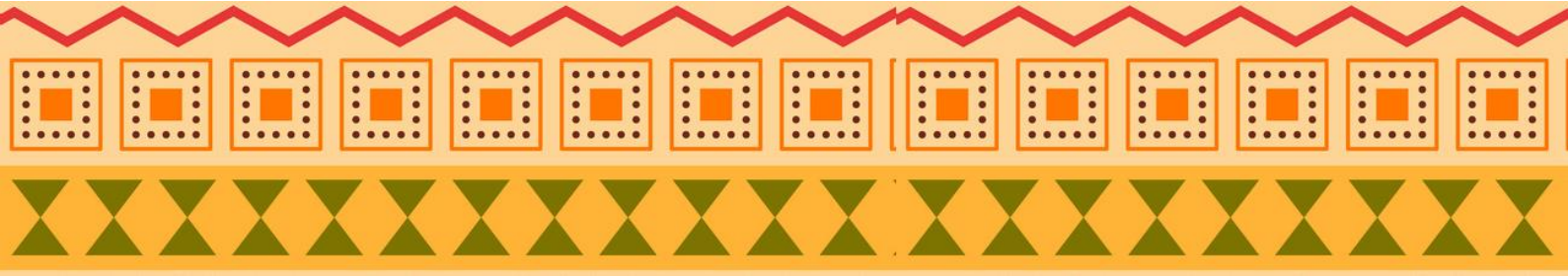
